**Notice Concerning Changes to Corporate Organization
and Changes in Responsibilities of Operating Officers and Key Personnel**

Duskin Co., Ltd. hereby announces that it has resolved, at a meeting of the Board of Directors held on January 30, 2025, to change the corporate organization, and also to change the responsibilities of Operating Officers and key personnel, as described below.

1. Changes to the corporate organization

This fiscal year ending March 31, 2025 is the final year of our Medium-Term Management Policy 2022, and we are now formulating the next medium-term strategic business plan. These days, digital technology and generative AI technology are rapidly developing. Therefore, quickly adjusting to and leveraging these cutting-edge technologies to improve productivity and transform our business models is one of the key themes in our next medium-term strategic business plan.

At the beginning of the fiscal year ending March 31, 2026, which is the initial year of the next medium-term strategic business plan, the IT Strategy Management department will be newly established to effectively implement and manage IT-related investments while optimizing the Company's IT systems as a whole. With this structural change, IT-related sections dispersed around various departments will be centralized under this new department.
